

Delta Dental Open Enrollment is from May 1–31, 2017

This year we are again pleased to announce there will be **no cost increase** to members and several enhanced benefits, while retaining all the outstanding benefits that members who participate in Delta Dental currently enjoy. The new enhancements include: Orthodontic coverage will be increased from \$2,000 to \$2,250; and a wellness D&P Maximum Waiver Option is now available where costs for covered diagnostic and preventive dental services don't accrue against plan year maximum.
